HBRRC opened in 1988 as an all-female reentry center. The facility is in the Beacon Hill neighborhood outside of downtown Seattle. Its residential location sits along a main bus line and has access to many local businesses. HBRRC offers a child visit day and overnight program for mothers and their children. The primary goal is to improve public safety by positively changing lives by supporting the reentry needs of incarcerated individuals transitioning into the community.

Residents who meet the screening criteria may be transferred to HBRRC 12 months before their earliest release date. The facility is leased and operated by the Washington State Department of Corrections and provides 24/7 safety and security, food services, case management and maintenance.
