## **CIM Matthew Blair response**

Commissary operations do offer several soft options for the population in the cookies and pastries category. Of the 15 products in this category, 6 are considered soft. These are pastry options more so than cookies. Item#'s and descriptions are listed below as examples of soft pastry options. If the population has a request for a specific item, Chewy Chips Ahoy cookies for example. A kite with the suggested item can be sent to the team at the MCC Commissary. The suggestion will be shared with operations at AHCC. These suggestions are added to the database maintained by Commissary Operations. When space is available on the production lines, suggestions from the population are shared with potential vendors. Depending on availability, price points and other factors. We can add available suggested products to the offering.

## **CPM Leslie E. O'Connor responses**

Handbook questions – *Although I am responsible for the handbook, it is created by numerous stakeholders. I need more specific questions to be able to get the right stakeholder involvement.*

Increase phone call time on tablets from 20 to 30 minutes – *This is a statewide contract issue and cannot be impacted at a local level.*

Securus “refusing” to release photos/music to recently released I/Is – *This is the first I’m hearing this. I need specific names/DOC numbers for follow up. If there are not specifics, individuals need to contact Securus directly as the contractor.*

Ice cream incentive program for TRU-updates – *The ice cream/snack cart proposal was approved by the Superintendents, all supplies have been ordered. We are still waiting for the storage cabinet to arrive. Once all supplies the memo and ordering information will go out to the population at TRU.*
