Family Member: Recreational supplies, before the end of the fiscal year is there any way to get a survey out to the population to see what they would like to have in the gym area? *A follow up email has been sent to recreation with this inquiry/request.
Financial Overview / IIBF LBA Hillard Mellin		Family Member: When does this budget expire? Hillard: Fiscal year closes June 30th. The items purchased must be on site by that date, not ordered by the date.
		Nolte: Can the IIBF hotel and transfer amount be raised from \$50 per visit as there appears to be so much money still left in that fund. Hillard: That is a question I will have to speak to HQ about. Please send me an email about that.

Nolte: Can the Incarcerated Individuals participate in a survey to see what other purchases they would like with **IIBF** monies? Bennett: There is not a local survey that I am aware of that goes to our population. However, SCCC has a great group of representatives through Tier Reps and Amend. Through their work and input we have been able to place bicycles and pull up/dip bars within the pods. Those don't show up as expenditures in our IIBF funds because we received outside funding with Amend.

Family Member: Are there expenses that have already occurred that are outstanding to this document? Hillard: Yes, there are March expenditures that are not reflecting on this report due to it being closed in February. Those expenditures will be reviewed at the next LFC meeting.

Nolte: I was told by a Tier Rep that paper towels equal out to about \$7 a roll through Cl. Hillard: We have a statewide contract through CI that states if they make a material that we need to purchase, we have to purchase from them, not another vendor. Nolte: How long is that Cl contract for? Hillard: I am not aware of when the contract ends or if it renews. Bennett: It is legislatively driven that we are required to work with CI. Working with CI

also helps with reentry for the

population.

Family Member: What are adult special programs? **Mansford:** That is the parents and mentors event in June. HQ does not call it an event like we do, that's why it is listed that way.

Family Member: What about restricted cultural events...what is that about? Bennett: That is brand new money that we were recently aiven from HQ. Across the agency facilities have received this money at per incarcerated to work towards funding facility cultural events. We have a number of different groups that will be having events. Looks like we will be splitting that amount up, roughly \$5 per Individual. HQ allocated the money, but they are still working through the restrictive processes. There will be more to come regarding these funds and what they will be spent on. Family Member: Hillard said the budget was closed as of February...the black history event happened on the last day of the month, so was that event not included in that fund? Bennett: Though it was not included in this fund, there are other options for funding for the events. Also, please note that not all the receipts have been received. This fund is still very new, and I am not a subject matter expert and do not want to misspeak about the use of funds. Family Member: Family Fun Significant Others event went well. 175 SCCC residents were able to attend a workshop with the Seattle Clemency Project and they are working on getting that project opened again for another workshop.

I spoke about SCCC's urgent care that was opened and then put on hold after 4 days. When I brought that up at state it seemed they were looking into it more and possibly expanding it MacDowell: We have a demand to bargain that starts in the beginning of May. Probably mid may we would be able to reimplement, we are gathering data and are very hopeful. Nolte: Was SCCC the 1st to implement an urgent care and now the whole state is looking at it.

MacDowell: That is correct. We were told to stop until the bargaining is complete.

Property has agreed to allowing an inclement weather area for pill line. It has been used recently when needed. If they send a substitution you pay for it. If they are always out of Irish Spring... I would suggest ordering something else in the meantime If you order it and they don't have it, and they don't give a substitution... they do not take the money.

The quality of laundry bags is still an issue.

Bennett: We are working on the laundry bag issue. I spoke with one of the department deputies about this to see if there is another source we could get them from. However, we are required to purchase from CI if they provide the product. To bypass that the department would have to get something in writing.

Family Member: When they do the laundry, they are not in a commercial washing machine, they're moving them around with a paddle correct? **Bennett:** No, I would refer to the machines as industrial. They are massive.

Family Member: The inventory of items that they are able to order, is that dictated by facility or statewide?

Bennett: That is a statewide order form, but different facilities have items that they do not allow due to custody level. There is a master list controlled by CI. However, I am unaware of any restrictions for SCCC.

Family Member: Can we see that list?

Bennett: I know there is a printed list somewhere and if the master list is available, we

		can put it in the notes. Family Members: It is available online. *Link was placed in the chat for family members. Please visit the website for master list.
Interim Election Facility Co-Chair Superintendent Jason Bennett	SCCC currently has 2 vacancies on their LFC, Family Co-Chair and Family Co-Secretary. An email was sent out requesting nominations for each position. No one accepted the Family Co- Chair position. 2 People accepted the Family Co-Secretary position: Catherine Antee and Kelly Keen. (see attached statement from K. Keen).	Catherine Antee: I am going to defer to Ms. Keen. I was going to do it if no one stepped up, but due to personal reasons I am going to defer to Ms. Keen if she would like to hold this position. Thank you so much for the nomination. Bennett: Thank you for being willing to participate and for all that you do. Bennett: Ms. Keen, you are no longer running in a competitive race, but would you like to still speak to the families? Kellie Keen: I am still very new, I'm here to help out in any compacity and here to help and learn. I am located in South Carolina and in a different time zone but will be making the meetings and helping very much. Bennett: For the sake of having an actual election, and to confirm her position, we will still send out an election notification through email for co-secretary. *An election email was sent to the SCCC LFC family members on Tuesday, 4/16 with a voting deadline of Saturday, 4/27.
	Roundtable / Open discussion	

Family Member: When you are sending memos could you please send it to us as well through the LFC email list? It used to be done, but it then changed. That could be due to a new Superintendent, but can we look at this?

Carlson: Please note that some of the notifications sent to the population are through kiosk announcements not memos. When those announcements are generated, I am not made aware. There have been times where and Individual is informing me of a recent announcement.

Bennett: Let me take a look at this, if I generate a memo then I'll make sure you get a copy. I'll ask Amber to help remind me of what I said. If it is not something that is shared by me or goes out through a HQ kiosk, we will look to see if HQ is posting it on an external website.

Family Member: Memos...the consistent carb diet that was offered to more than just the diabetic community, some have been getting it for the last 6 weeks. Then a memo went out saying you can't have that diet anymore....why was it jerked away from the population? Why were they not given prior notice? What happened?

MacDowell: During covid lots of HSRs were handed out that were not necessary. The actual policy for the diabetic diet states that they must be insulin dependent or approved by the Facility Medical Director. Then we started receiving lots of Individuals that did not qualify, so we screened and started going through the process for those Individuals to receive the proper diet. We are working with the other Individuals and getting them onto another diet that will work for them. Unfortunately, that notification went out a little earlier than I would have liked, but the Facility Medical Director and I are working very hard this weekend to get everyone screened and on a path to the correct diet. **Family Member:** I thought HQ, or the legislature gave extra money so facilities could have resources and expand their program.

MacDowell: The focus is preventive medicine and this whole diet issue is a very big deal to me, and we are trying to get everyone screened and good to go by mid-week.

Family Member: Does anyone know the difference in cost for the carb conscious diet versus the regular diet?

Bennett: Mr Attard is not on the call, Amber will get the cost breakdown of per meal for the notes.. *Action Item

Family Member: There is a lot of times that there is a line for bathrooms in visitation. Is there any opportunity for those bathrooms to be more accessible?

Bennett: We cannot leave it unlocked for safety and security, but I do know there is hourly and at request options.

Family Member: We come from Coyote Ridge and their visitor bathrooms are open.

Bennett: I agree in principle, and we can take a look to see what else we can do. Many factors (staff, officer stations, etc.) play into this. I will follow up with the Captain, CPM, Coyote Ridge, and other facilities on this. *Action Item

Family Member: I know this is a min/med facility, but I'm really concerned about the life without Individuals. Meaningful jobs, programs, and educations...I would like to know if there is something we can do to encourage these with life sentences to be contributing individuals to their population. For the distribution of information, I do not know who to go to get emails for people. Amber has been helpful through this, but I've had to call HQ to obtain email addresses for some people.

Bennett: We are always looking for opportunities. There is a focus for those with release dates, but we do look for opportunities for the population with the longer sentences. We are always looking at new programs and opportunities here at SCCC. Also, we can take a look at providing some email addresses for communication. *Action Item (email addresses)

Family Member: Fundraisers. They are not doing anything at SCCC. Several of the guys have stated they would like to do it again.

Bennett: We run into a volunteer and ethics issue with fundraisers. We were fortunate enough to previously have a staff member run them almost quarterly, but they have since obtained a position where it does not fit in their workload. I have met with the Tier Reps about a small subcommittee, so we will be looking at that as well.
