	 Susie stated that the following are topics for consideration of placement in work release: Ability to maintain a community living status is a safe manner Focused on obtaining/maintaining employment Infraction behavior while in a prison facility (serious or repetitive infractions may preclude placement in work release) If an individual transfers to work release and then is terminate, they would not be able to go back to work release during that incarceration (they would be considered for placement at a future incarceration, they will not automatically be denied) If concerns about an individual's crime do arise, the individual's case is reviewed by a team of staff that discuss all factors of the case and decide to approve or deny placement in work release
