DOC updated City Manager Hugill concerning the status of the search for additional sites in Snohomish county and of the upcoming meeting on 7/13/2021. He requested that DOC also inform Chief Caw and Community Relations Director Virginia Clough via e-mail and invite them to the 7/13 meeting. This was done on 7/12/21.

6/5/2020	Letter from Mayor Nehring, City of Marysville – Response to Work Release Expansion wr-expansion-snoh omish-county-comm
6/5/2020	Project lead reached out to the City of Everett to provide an update on the project specific to a location in Everett.
5/28/2020	Project lead reached out to the City of Lynnwood to provide an update on the project specific to a location in Lynnwood. No response has been received as of 6/5/2020.
5/15/2020	Project lead received a call from City Manager Scott Hugill of the City of Mountlake Terrace. He called in response to an informational/outreach email received about the project sent to the Mayor and Police Chief. Manager Hugill was briefed on the project and had specific interest in the MLT property. He was informed that MLT police Sgt Scott King had participated in the LAC meeting on 5/12/2020. He indicated that he would arrange for a briefing with the City Council and Mayor about the project for June.
5/7/2020	Project Lead spoke with Sgt. Scott King, Mountlake Terrace (MLT) Police Dept. concerning the LAC and a potential property located within the city of MLT. He was asked to make contact in response to outreach to MLT City officials concerning the process. He indicated he or another representative of MLT would be attending the May LAC. He was forwarded the meeting information.
4/30/2020	Project Lead provided an e-mail project status update to Marysville Mayor Jon Nehring. Mayor Nehring replied indicating he would arrange for a video tele-conference for the Police Chief, Community Development Director, Chief Administrative Officer and himself so they could receive more detailed information.
4/22/2020	Project Lead spoke with Susan Neeley of the Snohomish County Executive's office. She has been briefing CE Somers and will continue to engage the process either through other County Government representative attending the LAC or will participate directly herself.
4/22/2020	Project Lead spoke with Snohomish County Council Member Nate Nehring. The Law, Justice and Human Services Committee will schedule a work session to receive an update on the project as it relates to Snohomish County.
