Amendment No. 1

This Amendment is made by the state of Washington, Department of Corrections, hereinafter referred to as "Department," and Native American Reentry Services dba HEAL, hereinafter referred to as the "Contractor," for the purpose of amending the above-referenced Contract, heretofore entered into between the Department and the Contractor.

WHEREAS the Department and Contractor previously entered in a Contract to provide religious and cultural services dated July 5, 2016 (the "Contract"); and

WHEREAS the purpose of this contract amendment is to incorporate custodial supervision into the agreement.

NOW THEREFORE, in consideration of the terms and conditions contained herein, or attached and incorporated and made a part hereof, the Department and Contractor agree as follows:

1. The parties agree to modify Attachment B, Scope of Work, as follows:

I INTRODUCTION

Contractor will provide religious and cultural services to support the spiritual growth of American Indian/Alaska Native (AIAN) offenders at the Department facilities listed below and custodial supervision at WSP. Department policies and procedures will not be relaxed or compromised to facilitate provision of such services and services may not interfere with security, safety and orderly operations at any prison.

2. The parties agree to modify the Scope of Work by adding section 6 as follows:

VI CUSTODIAL SUPERVISION AT WSP

In an effort to ensure compliance with applicable laws, DOC policies and rules, and to ensure the safety and security of the offenders, the contractor will provide custodial supervision at WSP. Contractor will provide custodial supervision for sweat lodges, change of season ceremonies, and any other religious and cultural activities described in the Contract as assigned. Custodial supervision will be available up to 16 hours per week 2 times monthly and an additional 16 hours during "change of season" months.

The Contractor's custodial supervision staff shall complete annual in-service training. In-service training must be finished by June 30th of each year and can be completed online.

The Contractor will submit to the Department a monthly log detailing the services provided during the month and any problems that may have arisen during that time.

3. The parties agree to modify Attachment D to include a maximum of \$7,500 annually for custodial supervision at \$20 per hour for a total contract cost (including admin) of \$222,102 annually.

Additions to this text are shown by underline and deletions by ~~((strikeout))~~. All other terms and conditions remain in full force and effect. The effective date of this amendment is the date of last signature.
