- An updated prosecutor recommendation was received. The prosecutor opposes Mr. Roth's release.
- Martin Roth was seen for a .100 hearing on May 13, 2025 at the Monroe Correctional Complex – Twin Rivers Unit.
- **Summary Discussion**
Jill Getty presented the case to the full Board.
- Martin Roth is under the jurisdiction of the Board for their conviction of Rape in the First Degree and Robbery 1 in King County Cause 81-1-03003-0.

Mr. Roth raped an adult unknown female victim at gunpoint. He was 34 years of age at the time of the crime and is currently 77 years of age.

Previous Criminal History:

In April 1970, Mr. Roth was convicted of Rape in the First Degree in New Jersey. Approximately a month after his release on parole, Mr. Roth was arrested and convicted, in New Jersey, for Assault with the Intent to Rob. Upon his release, he moved to Washington State and shortly after committed the rape and robbery that he is currently incarcerated for.

Risk assessments show him to be a high moderate risk to re-offend.

Mr. Roth's last serious infraction was in 2018.

Mr. Roth has participated in several programs during his incarceration to include sex offense treatment, substance use treatment, Thinking 4 a Change, as well as Re-Entry Life Skills.

Mr. Roth will be returned to New Jersey to address a detainer.

- **Decision:**

The panel recommends Mr. Roth remain in confinement and that 48 months be added to his minimum term.

- **Reasons:**

- Mr. Roth is a high-risk sex offender who was revoked after a short period of time in the community, approximately six months, during which time he was highly sexually preoccupied and had numerous sex related violations.
- Additionally, he scores High on the Static 99-R (+6) and is assessed by the ESRC as a level Three for community notification.
- He also recently had a Forensic Psychological Evaluation (FPE) completed, which indicated he appears to meet the criteria under RCW 71.09 as a sexually violent predator, though that official determination occurs through a court process.
- He has a recent additional Psychological Evaluation, completed by Ph.D. Robtoy on January 9, 2025. The evaluation indicated Mr. Roth is a questionable candidate for release to a less restrictive setting and a

High Moderate risk for violent recidivism, including future sexual offending in a less restrictive environment.

- **Recommendations:**

- Other Programs, if eligible. Such as: Thinking for a Change, Redemption, Bridges to Life, Alternatives to Violence, Domestic Violence Treatment
- Remain infraction free and have positive interactions with staff
- Participate in next Hearing
- Develop a release plan/community support

- **Next Action:**

- Schedule a .100 Hearing approximately 120 days prior to PERD. Request an updated FPE for his next .100 Hearing.
