The line item below of "Incarcerated Individual Comfort Items" is part of the discussions with the \$75,000 Future Deployment Funds.
What is the plan for "future deployment"? The year is almost over and as we know if we don't spend these funds, we miss out on the opportunity.	As of quarter ending in March 2021, the budget to actual under this category is 65% with most of the facilities' purchases. As some of the facilities sent request in April, we will see more expenditures showing on next quarter's report. Just like other IIBF funds, the unspent portion from the allotment from current fiscal year will be part of the IIBF fund balance to be considered for next fiscal year's IIBF budget build.
What facilities were part of the comfort items? How much was allocated per facility? May we get receipts of purchases?	Ten out of twelve prison facilities have requested purchases from the IIBF Family Friendly Incarcerated Individual Comfort Items funds. The total spending is 65% from the total allotment. What type of charges go towards visiting? It's a small amount, but still curious to know what visiting spending comes out of the IIBF while visiting was closed. Same question for EFV and cultural events.	There were some mis- coded charges into Visit and EFV programs we discovered during the reconciliation and those will be corrected by the facilities.
Why did DOC make a decision to recover recreational fees when there are so many things in this budget that did not take place this year? Wouldn't that be better to let people finally use recreation for free at least for a few months?	The recovery fees under the IIBF non-restricted expenditures for recreation, tv and visiting programs are based on RCW and DOC policies of Inmate Contributions for Cost of Privileges.
I also want to ask about a situation at MCC. Since nearly the beginning of COVID the EFV trailers have served as housing for a set of individuals stationed at MSU who were said to be there because they were judged to be at high risk. The trailers were set up for a series of short EFV stays, cleaned and maintained after each weekend of visits. Some kitchen gear, electronic gear and other items were purchased by family. Most probably, daily living for over a year will have extracted a toll greater than the weekend visits. Leadership at the prison has told me that they would be looking at IIBF money to repair, refurbish and purchase whatever might be needed as they re-start the EFV program.
