The following is a summarized list of questions and answers from the audience of the IIBF Live Event Public Meeting on April 28, 2022. To the extent possible, they have been grouped by the category for relative response on the Budget to Actual Financial report.

EFV/Visiting Enhancement Information	
Are there family members involved in developing the lists of standardized equipment and supplies for EFV?	We created a standardized survey with families and incarcerated individuals. The big piece of the survey is to be able to provide suggestions and feedback to us and local facilities. In addition, we are working with Hands On Children's Museum for them to provide us feedback for child family areas at both EFV and Visiting. We will do another assessment in six months after EFV's are up and going again so we can continue to hear from families.
	We were also able to lower the cost of EFV fees. We heard concerns from the statewide family councils about the increase from \$10 to \$15. During the research process we realized that we should not have been allowing families to pay for this cost instead the incarcerated individuals should contribute. The cost is now \$5.00 and must be paid from the individual's trust account.
Will there be any expansion of units available for EFV?	Any expansion of EFV is a capital project cost so it is not associated with IIBF. Any added EFV units may necessitate additional staffing, so consideration has to be given for operational budget funding as well. For those of you who have concerns about EFV scheduling difficulties please work with your local administration so they can start the assessment for the possibilities of expansion.
Can someone tell me if our loved ones were asked about what things, and in order of importance they though were most important. Not just EFV, I am asking about every IIBF use of monies and which families were consulted.	The survey we sent out also went to incarcerated individuals, so they could provide us with feedback and allowed them to prioritize choices, they also provided us with input of use of IIBF funds. We are planning to conduct the survey twice a year in the future. The plan also includes to run the survey at institutional kiosks, we are building the program at the kiosk to collect and calculate the information and data.
Can we create an avenue for donations such as to EFV fees? People would like to help but don't know how.	We appreciate that. The only difficulty with that until the law changes, is the statute requires the incarcerated individuals to pay the fees. The IIBF budget team will brainstorm and consider your suggestions. DOC has a policy that explains how to make the donations.

With the contract with DOC vendors, is the agency getting commission from the Union Supply?	No. Union Supply orders run through Correctional Industries. No commissions come back to IIBF. The Union Supply contract is available at the DOC public website on the bottom of Commissary page. TV/Cable Services	
Have you heard complaints about the quality of TV/Cable services?	We have not heard any recent complaints regarding this. Part of our survey to the incarcerated individuals is the quality of tv/cable system. This is something we will follow up with the population to make sure we are getting the information from them.
IIBF Comfort Items and Credits Provided To Incarcerated Individuals	
How do individuals who were in IMU at the time IIBF funds were given to every individual for phone, spendable and JPay get those credits? The example is from AHCC	If there were individuals that stayed in certain housing areas that did not receive credits, there was a six-week period after the credits were applied in which to notify their counselor that a credit was missed, and that notification period ended 3/18/22. Credits were given to eligible individuals that reported issues within the notification period.
