**The individual is not eligible for placement on Electronic Home Monitoring as a participant in Graduated Reentry per DOC 390.590 Graduated Reentry because the incarcerated individual:**

- Is currently designated Close custody.
- Has a mandatory minimum sentence (enhancement time) that has not yet been completed, which must be served in total confinement as prescribed by statute.
- Is serving a Prison sentence for Escape 1 from a correctional facility.
- Is under the jurisdiction of the Long-Term Juvenile Board (LTJUVBRD).
- Has an open detainer (misdemeanor or felony).
- Has an open felony warrant (extraditable or not).
- Is subject to a deportation/Immigration and Customs Enforcement detainer.
- Has been denied custody promotion by the Headquarters Community Screening Committee.
- Has been found guilty of a serious infraction related to personal or community safety 6 months prior to eligible transfer date to Graduated Reentry.
- Has a serious medical/mental health condition and is not cleared for partial confinement placement as determined by the current facility's health services employee/contract staff.
- Has a Drug Offender Sentencing Alternative (DOSA) sentence that has been terminated and has been found guilty of a 762 infraction during the current incarceration.
- Is pending interstate transfer or intends to release out of state.
- Has been terminated from a partial confinement option setting on the current sentence.
- Is incarcerated as a result of a Community Custody Prisons or DOSA reclassification and has already served time in a partial confinement setting during the current sentence, and does not have time available to spend in partial confinement for Graduated Reentry per statute.
- Is currently incarcerated as a result of a Special Sex Offender Sentencing Alternative (SSOSA) revocation.
- Had or currently has an End of Sentence Review Committee referral recommending civil commitment.
- Is currently incarcerated as a result of a Community Custody Board revocation.
- Is under the jurisdiction of the Board and has not been determined releasable by the Board or is serving confinement time for a revocation.
- Has a recommendation of denial by Sex Offender Treatment and Assessment Program (SOTAP) due to individual Static Risk score and/or non-amenable to treatment.
- Does not or will not have three months or more left on their sentence at the time of eligible transfer date.
