- Minimum Security Classification Facility

#### Capacity:

- 81 men, 20 women

#### Annual Operating Budget:

- \$4,280,213

AVRC opened in October 1972. Since its inception, it has become an intricate part of Yakima's business and law enforcement communities. The facility is surrounded by orchards, hop fields and residential areas, as well as established and growing local businesses. The primary goal is to improve public safety by positively changing lives by providing residents with the knowledge and skills necessary for success in the community.

Residents who meet the screening criteria may be transferred to AVRC 12 months before their earliest release date. The facility is operated by the Washington State Department of Corrections and provides 24/7 safety and security, food services, case management and maintenance. The Department of Corrections owns the building.
