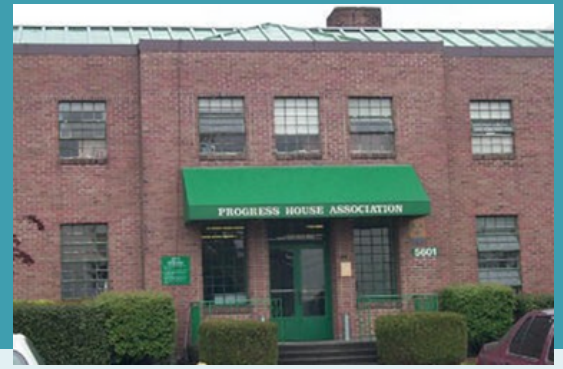


PROGRESS HOUSE REENTRY CENTER (PHRC)

Custody Level:

- Minimum Security Classification Facility

Capacity:

- 76 men, 14 women

Annual Operating Budget:

- \$2,032,238

PHRC is located in the northern area of Tacoma, bordering the water of Puget Sound. Well-established local businesses surround the facility in a residential community. PHRC has served the community since 1976. The primary goal is to improve public safety by positively changing lives and reconnecting with family by providing residents with the knowledge and skills necessary for success in the community.

Residents who meet the screening criteria may be transferred to PHRC 12 months before their earliest release date. The facility is operated in partnership with a contract agency that provides 24/7 safety and security, food services and maintenance. The building is leased from Pierce County by the Progress House Association.
