Airway Heights Corrections Center (AHCC)

- Number of new cases in last 30 days: 358
- Number of confirmed cases to date: 1,662
- Beginning Monday, January 25, 2021, incarcerated individuals housed in cleared units and alternate housing areas in the main facility will have extended outside recreation time. Currently the only units and alternate housing areas approved for outside recreation in AHCC Main are:
 - L-Unit
 - M-Unit
 - N-Unit
 - R-Unit B-side
 - T-Unit
 - E-building Recreation North Gym
- During recreation, individuals are required to wear a face mask at all times, socially distance, and are not to share equipment. All equipment will be sanitized between uses.
