Current Status

Medical isolation and quarantine among the incarcerated population

- Medical Isolation: separating a symptomatic patient with a concern for a communicable disease from other patients.
- Quarantine: separating from other individuals those who are not showing symptoms yet have been exposed to an individual with a contagious disease.
- Federal quarantine and isolation currently apply to the following diseases: cholera; diphtheria; infectious tuberculosis; plague; smallpox; yellow fever; viral hemorrhagic fevers; influenza caused by new or re-emergent flu viruses that are causing, or have the potential to cause, a pandemic; and severe acute respiratory syndromes (which may include COVID-19).

 - o 860 Incarcerated individuals in medical isolation
 - o 1,448 Incarcerated individuals in quarantine

Airway Heights Corrections Center (AHCC)

- Number of new cases in last 30 days: 254
- Number of confirmed cases to date: 1,662

Coyote Ridge Corrections Center (CRCC)

- Number of new cases in last 30 days: 41
- Number of confirmed cases to date: 394

Larch Corrections Center (LCC)

- Number of new cases in last 30 days: 281
- Number of confirmed cases to date: 281

Monroe Correctional Complex (MCC)

- Number of new cases in last 30 days: 327
- Number of confirmed cases to date: 402
- Incarcerated individuals continue to transition back C and D units at the Washington State Reformatory as they are cleared from quarantine.
- The Rapid Deployment Care Facility (RDCF) at the Twin Rivers Unit has been opened as an alternate housing area and is housing COVID-19 positive individuals. (see photo gallery)

- Individuals housed in cleared pods have additional access to outside recreation. As additional
 pods become cleared for outside movement, the outside recreation schedule will be updated to
 reflect these changes. Currently the only approved units in the main facility for outside
 recreation are:
