Current Status

- On February 2, 2021, an individual incarcerated at Airway Heights Corrections Center passed away at a community healthcare facility due to COVID-19 related illness.
- Per policy 450.100 Mail for Individuals in Prison, "electronic messages will be distributed to an incarcerated individual within seven business days" excluding emergency situations. As of close of business on Friday, January 29, the longest standing, undelivered electronic message is dated January 17 at the Washington State Penitentiary in Walla Walla a difference of 10 business days. The penitentiary was the only facility in excess of the policy-mandated seven business day timeframe.
