## Current Status

- [On the dates of January 26 and January 29, 2021](#), two (2) individuals, both incarcerated at Airway Heights Corrections Center, passed away at a community healthcare facilities due to COVID-19 related illness.

## Prison Facilities

### Airway Heights Corrections Center (AHCC)

- Number of new cases in last 30 days: 239
- Number of confirmed cases to date: 1,671
- Individuals housed in recreation/gym alternative housing areas, have returned to living units.
- The alternate housing area in the gym is in the process of being closed.

### Coyote Ridge Corrections Center (CRCC)

- Number of new cases in last 30 days: 43
- Number of confirmed cases to date: 396

### Monroe Correctional Complex (MCC)

- Number of new cases in last 30 days: 284
- Number of confirmed cases to date: 492
- Quarantine status individuals housed in WSRU B Unit are being moved to alternate housing in single cells.

### Stafford Creek Corrections Center (SCCC)

- Number of new cases in last 30 days: 190
- Number of confirmed cases to date: 1,166
- The facility has cleared the following pods, all of which have access to outdoor recreation:
  - G Unit B and C Pods
  - H1 A and B Pods
  - H2 A and B Pods
  - H3 B Pod
  - H5 A and B Pods
  - H6 B Pod

## Washington Corrections Center (WCC)

- Number of new cases in last 30 days: 169
- Number of confirmed cases to date: 966
- Access to outdoor recreation has resumed for units that are cleared from quarantine or medical isolation. The outdoor recreation movement is scheduled one tier at a time.

## Washington State Penitentiary (WSP)

- Number of new cases in last 30 days: 134
- Number of confirmed cases to date: 984
- Golf Unit has been removed from quarantine status and has resumed a normal movement schedule.

## Work Release Facilities

### Brownstone Work Release

- Number of new cases in last 30 days: 3
- Number of confirmed cases to date: 3
- Residents were provided with supplies to craft handmade Valentines for their children/families to be mailed out by staff.
