Current Status

Per policy <u>450.100 Mail for Individuals in Prison</u>, "electronic messages will be distributed to an incarcerated individual within seven business days" excluding emergency situations. As of close of business on Friday, February 5, the longest standing, undelivered electronic message is dated January 20 at the Coyote Ridge Corrections Center in Connell – a total of 12 business days. Coyote Ridge was the only facility in excess of the policy-mandated seven business day timeframe.

Airway Heights Corrections Center (AHCC)

- Incarcerated individuals continue to return to their assigned units and custody levels.
- The following units have been identified as cleared: L, M, R, T, and Minimum Security Unit C4 & C5.

Coyote Ridge Corrections Center (CRCC)

- Number of new cases in last 30 days: 9
- Number of confirmed cases to date: 396

Monroe Correctional Complex (MCC)

- Number of new cases in last 30 days: 287
- Number of confirmed cases to date: 496
- Minimum Security Unit C Unit Tier 3 has been placed on quarantine status.

Stafford Creek Corrections Center (SCCC)

- Number of new cases in last 30 days: 148
- Number of confirmed cases to date: 1,167

Washington Corrections Center (WCC)
