Current Status

Per policy 450.100 Mail for Individuals in Prison, "electronic messages will be distributed to an incarcerated individual within seven business days" excluding emergency situations. As of close of business on Thursday, February 11, the longest standing, undelivered electronic message is dated January 26 at the Coyote Ridge Corrections Center in Connell, WA – a total of 12 business days. Coyote Ridge was the only facility in excess of the policy-mandated seven business day timeframe.

Airway Heights Corrections Center (AHCC)

- Number of new cases in last 30 days: 174
- Number of confirmed cases to date: 1,671
- K Unit has been designated as a cleared unit. On February 11, 2021, K Unit individuals started participating in meal pick-up in the dining hall and continue to eat meals in the living unit.

Coyote Ridge Corrections Center (CRCC)

- Number of new cases in last 30 days: 43
- Number of confirmed cases to date: 396
- CRCC was removed from outbreak status on February 11, 2021.

Monroe Correctional Complex (MCC)

- Number of new cases in last 30 days: 209
- Number of confirmed cases to date: 523
- Minimum Security Unit C Unit Tier 3 has been removed from quarantine status.

Stafford Creek Corrections Center (SCCC)

- Number of new cases in last 30 days: 162
- Number of confirmed cases to date: 1,184

- Facility staff have made multiple housing moves to create bed space in Unit R1. These moves created the capacity necessary for intake separation, medical isolation and quarantine beds.
