## **Current Status**

• The number of active incarcerated individual COVID-19 cases within DOC facilities has decreased from 1,232 on January 15, 2021 to 95 on February 17, 2021.

# **Topic of Interest**

Vaccine Information

- On December 28, 2020, Corrections' began providing vaccine doses to staff and incarcerated individuals who met requirements for <u>Phase 1A</u>.
- On January 24, 2021, Washington state moved to Phase 1B Tier 1, which includes people 65 years of age and older.
- As of February 1, 2021, Corrections' began vaccinating incarcerated individuals who are over the age of 65 as supply allows.
- Specific dates are unknown due to limited doses, and incarcerated individuals are notified as they are eligible to receive the vaccine.
- Currently, Corrections' is only using the vaccine produced by Moderna.
- Receiving the vaccine is voluntary.

# **Prison Facilities**

#### Airway Heights Corrections Center (AHCC)

- Number of new cases in last 30 days: 51
- Number of confirmed cases to date: 1,671
- All living units, with the exception of N Unit A-side, are on COVID-19 cleared status.
- Incarcerated individuals have the opportunity to send out their in-cell hobby items this week.
- Alternate housing areas are being transitioned in preparation for resuming education and gym activities.

#### Monroe Correctional Complex (MCC)

- Number of new cases in last 30 days: 159
- Number of confirmed cases to date: 525
- Individuals who have been cleared from medical isolation status are moving from the alternate housing area in the gym back to living units in Washington State Reformatory Unit.

#### Stafford Creek Corrections Center (SCCC)

- Number of new cases in last 30 days: 147
- Number of confirmed cases to date: 1,184
- The facility is transitioning to movement by cohorted tiers for mainline meal pick-up, and pill and insulin lines. Previously, meals and medication were provided in living units.

#### Washington Corrections Center (WCC)

- Number of new cases in last 30 days: 74
- Number of confirmed cases to date: 972

#### Washington State Penitentiary (WSP)

- Number of new cases in last 30 days: 29
- Number of confirmed cases to date: 985
