As Corrections experiences a decrease in active cases across prison facilities there are continuous evaluations occurring in regards to the resumption of programming, education, work, and recreation where possible while following COVID-19 safety protocols to mitigate the spread of the virus.

Airway Heights Corrections Center (AHCC)
