Current Status

The Department of Corrections has updated its <u>COVID-19 vaccine data dashboard</u> to now differentiate between COVID-19 vaccine doses administered by the department to individuals in the department's custody from vaccines administered to others*. Data on this webpage is updated weekly on Tuesdays. As of Tuesday, April 13, 2021:

- **3,815** individuals in the department's custody have received a vaccine dose administered by the department
- 3,551 others have received a vaccine dose

*In addition to Corrections staff, some vaccine doses have been provided to contract staff, Office of Corrections Ombuds and Disability Rights Washington.

Topic of Interest

- The Washington State Department of Health (DOH) defines, within a DOC facility, an outbreak as:
 - Two or more confirmed cases of COVID-19 in incarcerated individuals occurring within 14 days who reside in the same living area OR
 - o One or more confirmed cases of COVID-19 in an incarcerated individual AND
 - One or more confirmed cases of COVID-19 in DOC staff working in proximity to the incarcerated individual case/cases occurring within 14 days

Incarcerated individual COVID cases occurring in intake separation areas are not included in (a) above. Management of multiple cases in intake separation areas will be discussed with Prisons Health Services Unified Command on a case by case basis.

Work Release Facilities

Longview Work Release

- Number of new cases in last 30 days: 1
- Number of confirmed cases to date: 1
- Longview Work Release has been removed from outbreak status.

Progress House Work Release

- Number of new cases in last 30 days: 7
- Number of confirmed cases to date: 23
