# Corrections' COVID-19 Bulletin

June 9, 2021 Bulletin 62



## **Current Status**

- There are no prison facilities on Limited Area Outbreak status or Facility Wide Outbreak status, compared to seven (7) in outbreak status on January 4, 2021.
- There are no work release facilities in outbreak status, compared to two (2) in outbreak status on February 1, 2021.

The Washington State Department of Health (DOH) defines, within a DOC facility, an outbreak as: Limited Area Outbreak in a prison facility:

- Two or more confirmed cases of COVID-19 in incarcerated individuals occurring within 14 days who reside in the same living area OR
- One or more confirmed cases of COVID-19 in an incarcerated individual AND
- One or more confirmed cases of COVID-19 in DOC staff working in proximity to the incarcerated individual case/cases occurring within 14 days

Facility Wide Outbreak in a prison facility:

• Two or more Limited Area Outbreaks that are connected, occurring simultaneously in the same facility.

- 8,230 Incarcerated Individuals have received at least one dose of COVID-19 vaccine
- **3,723** Staff\* have received at least one dose of COVID-19 vaccine
- 18th out of 50 states for <u>number of positive cases</u> (Data from <u>covidprisonproject.com</u>)
- **21st** out of 50 states for <u>cases as a percentage of the population</u> (Data from <u>covidprisonproject.com</u>)

#### Coyote Ridge Corrections Center (CRCC)
