Current Status

The Washington State Department of Corrections' (DOC) COVID-19 bulletin will transition from once a week on Wednesdays to twice a week on Tuesdays and Thursdays starting on September 14, 2021. DOC recognizes the importance of communicating regularly and effectively as COVID-19 cases continue to rise across Washington State.
