Current Status

The Department of Corrections continues to be focused on mitigating the transmission of COVID-19 and regularly reviews and updates its protocols based on guidance from the Washington State Department of Health and the Centers for Disease Control.

Numbers at a Glance

- 2,111 Total Staff Cases have had COVID-19 to Date

Clinical Corner

From the HQ COVID-19 Clinical Leadership Team

Once again there have been headlines highlighting another new COVID-19 variant, now named Omicron. The development of variants is a normal and expected outcome for a virus over time as it continues to spread in a population. Most of these variants come and go without much impact. Sometimes a new variant has an advantage over other strains or variants of the virus, which are referred to as Variants of Concern (VOC). Since the Omicron variant is quickly spreading in many places, there is concern that this means that Omicron can spread more easily than the current existing strains, including Delta. So far, there is no evidence that the Omicron variant causes more severe disease or that our current vaccines and medications will not work against it. However, since this is always the concern, scientists are quickly trying to learn more about this new variant while attempts are being made to temporarily slow the spread. The best ways to prevent getting COVID-19 have not changed and still include washing your hands, wearing your mask, trying to distance from others, and getting vaccinated!
