Family Member: Items have to be purchased and delivered by July 1st?

Mellin: June 30th is the date for it to count towards this fiscal year? Family Member: Who do I email to get additional things covered by this fund? Is it Diane Dugan? Mellin: That is correct. Bennett: Repairs and replacements can be started at a local level, and we can reach out to Diane Dugan. Please remember that this report is 6 weeks behind so some of the money you are looking at today has already been spent. Our August meeting will cover that more.

Nolte: I have emailed you (Mellin) regarding the vouchers. Families may choose to use the family reimbursement for the 2 nights. Does that mean they can claim the \$50 for the 1st night and \$50 for the 2nd night as well? **Mellin:** I will look into that. **Nolte:** During the SFC meeting in May and asked if the payments can be made retroactively and she said no one had asked that and will look into it.

Family Member: I can answer some of those questions. Before the visit you have to send in the request notifying them that you will be coming for a visit. After the visit you submit your receipts. They also want to know your dates so they can document it. Diane (?) has stated that you can receive that money 2x a month if you are coming from over 300 miles. But you cannot get both lodging and gas. So, it is either 2 nights or the gas money per person.

Nolte: That is different from what Dawn Taylor has sent us. Hilliard: I will check into that *Action Item

Family Friendly Updates

CPPC Branwyn Mansford

Parents and Mentors has a full list and a significant wait list. We will be having activities outside if the weather permits. The rescheduled spring event will be held on July 13. That is child focused and will be outside as well.

Signups for both events are closed.

Back to school signups will start June 11th.

The next Family Fun Night is July 19.

For 2025 we are planning to have an adult event "Celebrating Support" outside. Celebrating Support was originally Dudes Day, then changed to Parents and Mentors. However, we noticed this year that we needed to broaden the support systems even more now that we are offering it as the adult event outside.

We were able to purchase graphing calculators for our older kids who attend the Back-to-School event. We also purchased an inflatable obstacle course and a new camera that will be used for our events and the video gram program. We also got approved for mini-USBs for our send out program.

Volunteers and programs: 4 new onboarded in May and a few more that we are onboarding at other facilities.

A new non-denominational service has opened for Sundays. That was approved and all put into place Friday, allowing us to build a call out for this week. Family Member: The spring event list has closed. When will notifications go out. Mansford: They went out Thursday afternoon by kiosk. For the most part...if you signed up and qualified, you made the list.

Girls Scouts Behind Bars: This organization has expanded and are looking to come into SCCC. This program allows parents, grandparents, aunts, uncles, brothers, sisters to be scout leaders for children in their own families. The children are allowed to come in and be part of this group that is made up of other children who are impacted by incarceration. They have had great success with this program at both Monroe and WCCW. They would be coming to SCCC every other month, and in the off months they meet via zoom. They will transport the kids to avoid a burden on the outside families.

However, in order to do this, we will need to take a half hour off of visitation every other month. By doing that it allows ample time for processing and ensuring the safety of the group's visitors.

Bennett: One of the things we wanted to bring to this group is that though would be a minor impact to the visiting program 6x a year, we feel that there would be a significant benefit in having this program at our facility....but wanted to reach out to the family council for thoughts.

Family Member: Did you send this to the population for their thoughts? Also, could there be an email sent out to the LFC with more information on this program. **Mansford:** We have not sent out any information yet as we would like to make sure everything falls into place first. Then we will send

Roundtable / Open discussion

Bennett: In response to an email, I received about EFVs - We have the same amount of EFV's as most of our partners. I have received a request about adding more but please note that it is a rough estimate of \$100k to have one built. We had a temporary trailer here that I inquired about purchasing but it was well over \$70k and wasn't truly available due to the required wind compliances. We are not opposed to adding more, but it is a process, it is a long-term process

Family Member: These certificates that the population are allowed to get on their tablet...if they want to receive any credit it will cost \$80 for them to take the test. Where is the funding coming from? IIBF or will we need to send in money? Also, taking these tests requires an educator to be present, none of this has been explained well to the population and/or the families. The pel grant is only for college credit and tuition...is this \$80 considered part of the tuition and how is this going to help them obtained the education.

Bennett: This email just came out from HQ on Thursday and have not been able to dive into all the details. **Family Member:** I received the information via distribution. So, I went to their website and looked into it more. When you watch the video where it shows the \$80 fee. I am drafting an email to Ms. Arnold with all of this as she did not know about the video either. Would GHC know about this funding even?

Bennett: I don't believe GHC would be able to assist with this. This all came to us on Thursday, and we are catching up on this process and am more than willing to look into all of this more.

Bennett: I had an email related to enhancing the role-playing games. I am working with HQ by asking if we are now going to allow multisided dice, and other additions to these type of games. Regarding the cards... there are issues with the specialty cards is that can have value much like a baseball card. Which can then be turned into an underground currency. So, we are asking HQ regarding all of these questions and will not allow further enhancements if it is not approved by HQ.

Family Member: Cable fee...they are paying their funds but with the HD channels are not coming in. There is something about SCCC needing to be rewired? What about the TVs in the gym are they being used yet? **Bennett:** I have not heard about this (SCCC needing to be rewired), but will inquire with our plant manager about the differences with the signal coming through for the HD channels. I do know they are working on the install, and we are hoping for a seamless transition when we go to the new carrier.

The TVs in the gym have been on and are being used. We did have 1 of the TVs with a picture issue due to someone throwing something but it was not a significant impact.

Family Member: Last month the SBU pod had a talent show. It was recorded and there was talk about putting it on a disk to show to the population. Is this still being worked on?

Bennett: Not at this time. Unfortunately, we do not have a way to edit it due to the way it was recorded. There was some questionable material but in large it was reported that there was a lot of good things included in the program. However, there was concerns brought forward by the population regarding some content from the program and we do not want any part of the population to feel targeted.

Family Member: You do not have the technology to edit it?

Bennett: There is technology available but there are current obstacles with our allowed technology that we

are able to use.

Nolte: For the talent show next year...maybe we can warn the participants about appropriateness as it is being recorded.

Bennett: Yes, next year we will be making a note that we do not want to interrupt community standards **Nolte:** Update on fundraisers?

Bennett: I do not have a good answer for that one right now. It does come down to me needing volunteers from staff or our volunteers that come in. It cannot be family members. The struggle is I cannot direct a staff member to help with a fundraiser, especially in my position (Superintendent). We are also looking at trying to find fundraiser options that are not so labor intensive. We are looking at breaking it up and maybe doing a fundraiser for a ¼ of the population at a time. We have to be very mindful of the Ethics board, especially when we utilize staff.

Nolte: Does there always have to be a DOC volunteer as well as outside volunteers?

Bennett: There is almost always a staff person involved.

Family Member: Tier rep minutes, can we send out those minutes to the LFC? Visitation - is there anything we can bring besides our diaper bag that they can lay them in? When you have a 9-hour visit...that is a long time for visitation with an infant. What if anything can be donated for playpens or bassinets for babies to be laid down in?

Bennett: Are we allowing stroller?

McGinnis: Yes, we have strollers available in the public access area. We do allow for car seats to be taken down, but it goes through the search process.

Family Member: So, for clarification...If I brought the car seat down next time...and wanted to lay him down...I can have him in the car seat with us at the table.

McGinnis: Yes

*The most recent Quarterly Tier Rep notes were sent to Co Secretary Carlson's LFC Families email list **Family Member:** With the new EFV policy there is a new cancellation list implemented. Has this been started.

Bennett: I do not know where we are with that. We will have to look for that information.

Family Member: The new policy states that the Superintendent is responsible for the decision regarding the cancelation list. This list would be beneficial for those who live close and can get there in 12 hours or less. **Bennett:** The policy states that I am responsible but please note that things do get delegated out. I know there is an OM (Operational Memorandum) being worked on. *Action item

Family Member: Can we use some of the non-restricted funds to purchase 2 pack and plays to keep in the visit room for instances like we heard a family member speak about today?

Bennett: We can see if that is an option. I will follow up with the Sgt. about that. *Action Item

Nolte: Top-Down Show Down Tournament Update:

Bennett: There was a competition around completion of timely room searches and property compliance. This was created by some staff to encourage others to complete searches noting we were not meeting all the agency required time frames. The focus was on quantity and quality noting that staff were encouraged to complete good searches focused on "search to find" and remove serious contraband and not just go through the motions of a search. The goal was never infractions but rather to remove dangerous contraband and keep the population safe.

As there was a negative perception, I directed that the competition be terminated and verified that it was. The searches themselves are required by agency policy, so the population will continue to see the searches. What has ended is the competition between the units and any tracking for competition purposes.

The policy regarding <u>Searches of facilities</u> outlines the requirement that each room is searched a minimum of every 60 days. The noted searches were required by policy. The cancelled competition was focused on meeting the policy requirements where there had been a previous gap and corrective action surrounding the concern. The rooms that were searched were required to be searched, the only direct impact of the competition was to motivate staff at being timelier and more thorough in the completion of their duties. The increase in attention to detail is part of what we should be seeing on a regular basis, however it is not

what the population is used to seeing so it feels a little odd.

The thought that staff would risk placing contraband for the infractions...that is not tolerable. If I was made aware of this, I would look into grounds for termination.

There were no policies that were broken, there was a perception issue. The intent of the staff members who created it was positive...To get all to complete searches properly and be educated regarding what they are allowed to have and what they are not. The tournament has been canceled but searches will still be done, and we hope to have them completed properly.

I want to make sure to reiterate that the risk is so high for a staff member to bring in and plant contraband that it is not worth the potluck prize. We want to hope for positive interactions from our staff and population.

Youth participants meet once each month with their justice involved loved one, alternating between inperson and virtual settings. Youth are also invited to participate in GSBB community troop meetings, programs, and events.

Can you see yourself as a leader?

Not only as an individual who is incarcerated, but as a leader who guides and instructs, who advises and discusses. As a troop leader who helps carry out responsibilities within the troop and helps youth build their skills and ethics.



Leadership opportunities offered through the program:

- Establish and maintain a healthy relationship with their youth
- Leader workshops to support resiliency and a growth mindset
- Goal setting for yourself and youth
- Certificates of Merit acknowledging your accomplishments

How does the GSBB Program work?

- GSBB staff are employed by Girl Scouts of Western Washington (GSWW).
- GSWW values and incorporates Diversity, Equity, and Inclusion (DEI) in all areas.
- The program is offered at no cost to the family.
- GSBB serves youth ages 5-17 through programming tailored to their age and Girl Scout level.
- Offered monthly:
 - Leader-workshop meeting
 - Leader-youth troop meeting
 - Youth only troop meeting
- Facilitation support, supplies, and materials are all provided by GSBB Program.
- GSBB staff work with your youth's guardians to support participation.
