The current proposal plan will harm families, relationships and the men. The people making these decisions are not the ones impacted by these changes. Families need to be included. What is the purpose of adjusting the visiting hour check in times? The likely consequence will be fewer opportunities for families to visit their loved ones, leading to frustration on both sides—both for the incarcerated population and their families. Requiring visitors to use the restrooms in the front lobby seems completely unnecessary and counterproductive. This will not only increase the workload for staff but could also facilitate contraband attempts and waste valuable time for families coming to visit. For those with young children, this creates even more logistical challenges, as they may need frequent restroom access in a safe and clean environment. Having to go outside repeatedly will only add stress and inconvenience for families who are already navigating a difficult process. We are already not using the same restrooms as the incarcerated individuals, so what is the reason behind this decision?	This was all retracted. The changes are all put on hold while HQ looks at Visiting rooms processes statewide. All visiting room processes are being reviewed for consistency.  Any changes will be added to the website.
